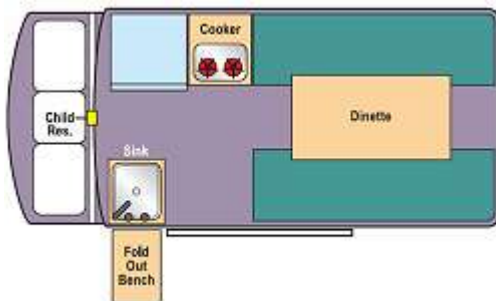

# Terms & Conditions Of Sale

## Camperman Australia Group Pty Ltd Terms and Conditions for the period 01 April 2010 to 31 March 2011.

1. **DEFINITIONS:** The following definitions apply for these Terms & Conditions for Camperman Australia Group Pty Ltd. Camperman Australia Group Pty Ltd is herein referred to as CAMPERMAN. The buyer is herein referred to as the BUYER. NIGHT is defined as the time between sunset on any day and sunrise the following morning.
2. **VEHICLE CHECK out time:** Vehicle pick-up and drop-off must be between 10:00am and 3:00pm weekdays or between 8:00am and 11:00am Saturdays. On Saturdays, please arrive at least an hour prior to the depot closing time (closing time is 12:00pm).
3. After hours pick-up and drop-off may be made by prior arrangement at a cost of AUD\$100.00, payable on pick-up or drop-off. All depots will be closed on Sundays, Christmas Day, Boxing Day (26 December), New Years Day and Good Friday and Easter Monday.
4. **ADMINISTRATION:** Monday to Sunday: 8:00am to 8:00pm.
5. **HELPLINE:** CAMPERMAN Head Office offers a 7-day-a-week Australia-wide help and information service. Please call TOLL FREE on 1800 216 223 for on-road service.
6. **MINIMUM Period for Buy Back is 180 days.** Dropping off at a different depot. Unauthorised drop-off to a depot other than that contracted for (as stated on the Buy Back agreement) will result in a fee being charged to the BUYER of AUD\$750.00 being charged to your credit card.
7. **EARLY DROP-OFF:** There will be no refund for early termination of a Buy Back. There is no refund available for the unused portion of the Buy Back.
13. Payment can be by Credit Card Master Card or Visa,, Debit Card, Bank Transfer, Swift Transfer.
14. **DEBIT CARDS** can be used by EFTPOS. All transactions will be conducted in Australian Dollars.
  - a. All charges incurred by CAMPERMAN in respect of parking or any other traffic violations during the period of the Purchase. (These will be charged to the Hirer's credit card plus an AUD70.00 administration fee per fine whenever CAMPERMAN becomes aware of such violations).
  - b. The BUYER is totally responsible for all loss of, or damage to the motor vehicle (including loss of use) cost of the vehicle, legal expenses, towing and recovery charges where:
  - c. The vehicle is totally or partially immersed in water regardless of the cause.
  - d. The interior of the vehicle is damaged (regardless of cause).
  - e. The vehicle is damaged by driving it under or into an object lower than the height of the vehicle. Please be careful when parking under trees or when entering a building that the height available is higher than the height of the campervan or motor home.
15. Registration and third Party Government tax is payable by the BUYER. The registration transfer fee is payable by the BUYER.
16. **GAS:** The gas bottle is full on delivery.
17. **FUEL:** The fuel is full on delivery.
18. **CAMPERMAN'S LIABILITY:** CAMPERMAN will not be liable to the BUYER. The photos on our website are taken by the staff of Camperman Australia and are updated monthly.
19. **TYRE DAMAGE:** The BUYER is responsible for All tyre damage while travelling after their purchase of the vehicle. Tyre damage, flat tyres, spiked tyres are at the cost of the BUYER. Average tyre prices in Australia are AUD\$125.00, so please take care of the vehicle's tyres.

20. VALUABLES: CAMPERMAN assumes no liability for valuables left in or stolen from the vehicle. Please do not leave valuables in the vehicle because of possible theft. In major cities it is advisable to leave the vehicle in a Caravan Park and take public transport to the city. Please note: Insurance on personal property is responsibility of the BUYER.
21. TRANSFERS: Transfers to and from CAMPERMAN in Cairns are available. Not available in other locations.
22. WARRANTY:
  - a. CAMPERMAN's vehicles are covered by a One Year Australia wide Warranty. Australia Warranties have been in the Warranty business for 20 years. Your vehicle warranty is available to be used in all towns in Australia. The warranty covers all mechanical items.
23. LIVING EQUIPMENT: Living equipment, as detailed in the line drawings, is included in the vehicle.
24. INSURANCE The Campervan or Motor Home can be Insured with the Motor Home Club of Australia. This can be arranged by Camperman Australia. Normal yearly cost is approximately AUD\$450.00. This can be paid directly to the Lumleys Insurance Company. A Cover note can be arranged prior to pickup.
25. ACCIDENTS Most accidents occur for the following reasons, all of which are avoidable:
  - a. Driving too fast. Driving on the wrong side of the road.
  - b. Turning across oncoming traffic.
  - c. Driving while sleepy and tired.
  - d. Collisions with animals.
  - e. Whilst reversing the vehicle.
  - f. Driving while intoxicated.
  - g. Driving at night. Camperman Australia is aware most accidents happen at night so we have added an excess of \$1000.00 for accidents that happen at night (night is defined as the hours between sunset and sunrise).
  - h. Looking for kangaroos at night (or at dawn or dusk) when they come to the side of the road to eat the sweeter grasses.
26. CONTRACTUAL RIGHTS: By signing this Terms and Conditions contract, the BUYER accepts that the Terms and Conditions make this an Australian contract and that the BUYER will be bound by the Australian State Law in which State this Agreement is contracted. This contract overrides any other contract form or contract taken in any other country. Any changes made to this contract may only be in writing and signed by the BUYER and an authorized agent of CAMPERMAN. CAMPERMAN makes no express or implied warranty in relation to this Agreement.
27. KEYS: The BUYER will be responsible for the cost of replacing keys which are lost or broken, or for the retrieval of keys locked in a vehicle. Cost of a locksmith travelling to the vehicle will be at The Hirers' expense.
28. PAYMENT IN AUSTRALIA All payments to be paid in Australia will be in Australian Dollars (AUD\$) only. No foreign currency will be accepted.
29. DISCLAIMER all illustrations, line drawings and text in any of our brochures or advertising material, including our website, are a representation only of the vehicles depicted. Variances in any vehicle or its equipment offered for rental may occur due to modifications and/or upgrades.
30. EXCHANGE RATE/CURRENCY FLUCTUATION All credit card transactions are conducted in Australian Dollars (AUD\$). Due to exchange rate fluctuations there could be some variation in the amount initially debited against the credit card and the amount refunded when the vehicle is returned. CAMPERMAN accepts no liability for these variations, up or down.
31. ROADSIDE SERVICE. We will join you in the RACQ Roadside Service Organisation for 24/7 Roadside Assistance. You have 24 hour road side assistance. Be aware if you have left your lights on and flattened your starting battery the call out fee is to your account.
