## Conditions of entry

### Entry

• Information on how to enter forms part of these Conditions of Entry. Entry into the competition is deemed acceptance of these Conditions of Entry. If you do not agree with any part of these Conditions of Entry you should not enter the competition.

• You are only eligible to enter this competition if you:

- are aged 18 years or older, or are under 18 but have parent or guardian consent to enter; and
- have exclusive intellectual property rights (including copyright ownership) in relation to the photograph(s) submitted in your entry.

• High-quality prints of photographs should be submitted, photos with less than 1200px width will be rejected.

• Photo must contain camperman from Camperman Australia.

• All entries must meet the requirements set out in these Conditions of Entry.

Entries that do not meet these requirements may not be accepted or considered for judging. Camperman Australia may determine in its discretion whether each entry meets the requirements. The following types of entries will not be accepted:

- Entries that contravene any law, infringe the rights of any person or are obscene, offensive, potentially defamatory, discriminatory, indecent or otherwise objectionable or inappropriate (this includes, any content involving malice, excessive violence or swearing);

- Entries that violate another person's copyright or intellectual property rights;

- Entries that include language or imagery that is discriminatory, rude or harassing;

- Entries that are spam or intended to cause technical disruptions to email servers;

- Entries that are considered by Camperman Australia to be potentially distressing, such as photos of natural disasters or sacred sites;

- Entries that communicate a potentially objectionable or inappropriate advertisement or message;

- By submitting an entry to this competition, the entrant warrants that they hold all intellectual property rights (including copyright) in each photograph submitted for the purposes of this competition. The entrant consents to Camperman Australia engaging in an action or omission which may infringe the entrant's moral rights in relation to their photograph(s). ### Judging panel

• The competition will be judged by the removeCamperman Australia's judging panel. The judging panel will consist of employees of the (remove) Camperman Australia and industry experts selected by Camperman Australia in its absolute discretion. The decision of the judging panel is final.

• Camperman Australia may, at any time, disqualify any entrant who, in the opinion of Camperman Australia, has not complied, or does not comply, with these Conditions of Entry or a law applicable to the entrant, or who has engaged in any unlawful or improper misconduct which jeopardises the competition.
